CONDITIONS FOR THE INTERNATIONAL BODY PAINTING CONTEST

ANNOUNCEMENT AND ENTRIES

- **1.** This contest is open to all persons of legal age who apply in advance to inscripciones@promocionlaspalmas.com, from 01 November to 30 November 2022. Entries must be confirmed by completing form **MC-1.**
- **2.** Those taking part must meet the following conditions and provide the corresponding documentation:
 - a) They must be at least eighteen (18) years of age on the day the contest is held.
 - b) They must provide a photocopy of their DNI (identity card) or passport together with the entry form.
 - c) The entry form MC-1 must be completed in full, with the correct and definitive information regarding the body-painting artist, model, sponsor, name of the body-painting fantasy and members of the body-painting team.
 - d) Participants must provide the music that will accompany the presentation of the model with a maximum duration of three (3) minutes, **on a pen drive**, to be delivered at the carnival office in Edificio Miller in Santa Catalina Park. Sending the audio file by email will not be accepted.
- **3.** The organizers may, if they deem it appropriate due to the number of entries received, hold the necessary preselections to designate a number of contestants not exceeding 25 to go on to the final selection. This preselection will be carried out by presentation of a sketch or photograph.





CONDUCT OF THE CONTEST

- **4.** Any theme may be chosen. The body painting must be original and unpublished, although it may represent any character or idea, real or imaginary. Various adornments and materials may be used provided that they do not cover more than **20%** of the body.
- **5.** The body painting will be carried out entirely within the enclosure set up for this purpose and will keep within the established time limit of a **maximum of seven (7) hours,** so that work may not begin until **14.00 (2 pm)** on the day the contest is held. It may be carried out by a team composed of a **maximum of three (3) persons**.
- The staging may include a maximum of four (4) extras.
- 7. The starting order will be established by drawing lots, which will be conducted in the place stipulated by Promoción de la Ciudad de Las Palmas de Gran Canaria S.A. and always in the presence of the body painters.

COMPOSITION OF THE JURY

8. The members of the jury and the secretary will be appointed by Promoción de la Ciudad de Las Palmas de Gran Canaria, S.A.

At least 60% of the jury must be made up of people directly related to the body painting, cosmetics, visual arts or performing arts sectors.

The organizers are responsible for ensuring that the members of the jury have a broad knowledge of the Las Palmas de Gran Canaria Carnival and will provide them with all the necessary information for this purpose.

The jury will visit the models in advance before they go out on stage, giving it a first contact with the works.

The members of the jury will not award points for this visit.

SCORING SYSTEM

9. The members of the jury, who will make their assessment on an individual basis, will take the following aspects into account when awarding points:





- From 1 to 10 points: originality, technique used, colouring, finish.
- From 1 to 5 points: choreography and staging.
- **10.** In the event of a tie the jury will vote again until the prizes stipulated in Clause 11 have been awarded, and may declare void the prizes it deems appropriate, given the quality of the body paintings presented.

In all cases the jury's decision will be final.

PRIZES

11. The prizes established by Promoción de la Ciudad de Las Palmas de Gran Canaria, S.A., are as follows:

| - First Prize | €2,500 |

| - Third Prize | €1,000 |

The amount of each prize will be received by the person in whose name the entry was submitted and **the amounts will be gross**. The appropriate legal withholdings will be deducted from them.

PENALTIES

12. Failure to comply with the time limit stipulated in these conditions for the performance of each participant will be penalized as follows:

- overrun of less than one minute 5 points
- from one to two minutes disqualification

If it comes to the attention of the jury or of Promoción de la Ciudad de Las Palmas de Gran Canaria, S.A. during the course of the contest that a body painting is a mere reproduction of any other body painting that has been awarded a prize in another competition of similar characteristics, it will immediately disqualify the participant. In the event that the evidence is provided after the decision has been announced, the jury will withdraw the prize and move the next participants up the scoreboard.





- **13.** The use of the following in the contest is prohibited:
- Any kind of pyrotechnic element, as well as flames in torches or candles, with oil, gas or any other type of fuel. The organizers will monitor the access of participants to the stage in order to avoid any risk associated with these products.
- Animals.
- Confetti, paper or spray streamers, or any other material that for safety reasons could put the normal conduct of the show at risk.

GENERAL OBSERVATIONS

- **14.** Promoción de la Ciudad de Las Palmas de Gran Canaria, S.A. reserves the right to modify the procedure, place, date and time of the event, if necessary. It may make whatever decisions it deems appropriate in the event of unforeseen circumstances that may arise during the course of the contest to ensure that it runs smoothly and has a successful outcome.
- **15.** Promoción de la Ciudad de Las Palmas de Gran Canaria, S.A. will under no circumstances accept responsibility for loss, damage or theft of any type of material (stage elements, costumes, tools and similar) that might occur in the Carnival venues, either onstage or backstage, and participants are therefore solely responsible at all times for the safekeeping of the elements used in their performance, and from the moment they arrive at the venue until they leave it.
- **16.** Participating in the contest implies acceptance of all the sections of these conditions.

SAFETY INSTRUCTIONS FOR PARTICIPANTS (*) IN THE CONTESTS

(*) For these purposes, "participants" is understood to mean not only those who have entered each of the contests as such, but also all those persons who are involved in one way or another as assistants, collaborators, body painters, hairdressers, dancers, support team, etc.

- You must obey the instructions of the security and event organization staff and comply with the rules of the venue where you are. See especially the Emergency Plan.
- In the event that you attend with small children or minors, their movements must be controlled at all times.
- If you feel unwell (fainting, dizziness) or suffer any injury during the show, you should seek the attention of the members of civil defence or medical assistance located inside the venue.
- On entering or leaving, do not stop at the gates, as you may block them and cause serious hazards.
- In the event of risk or emergency, stay calm and leave the enclosure quickly. Do not run. Follow the instructions of the security services.
- Do not bring in objects such as bottles, cans, sticks, flares, etc., that could endanger your own life and those of other members of the audience.
- If altercations or acts of violence take place, try to get away from the scene and inform the security and law enforcement personnel.
- Find out where the exits are, especially the emergency exits, and in the event of evacuation take the nearest exit.
- In the event of fire you must leave the venue by the nearest exit or the one next to it if it is unusable due to accumulation of smoke.
- It there is smoke in the enclosure, protect your airways with a handkerchief or something similar and leave the venue, crouching as low as possible.
- Before entering the venue, if you are accompanied by other people, select a reference point outside so that if someone gets lost you can meet up again.
- Remain calm and composed in any emergency.
- Request the help of the security services in any personal or collective emergency that may occur.
- Do not light fires or matches or use bangers, firecrackers or similar items.
- Do not make unauthorized electrical connections.

REMEMBER:

- It is strictly forbidden to climb onto railings, gates or other places not designed for this purpose. Similarly, do not block the emergency exits.
- To avoid accidents, leave the venue in an orderly fashion, respecting the order of exit.
- Uncivilized behaviour can cause a catastrophe.
- The greatest disasters are caused by disorder and haste.





- Your safety and that of the rest of the audience are more important than the show.
- In most cases the solution to the problem will depend on your behaving calmly.
- The security services are in the venue to keep you safe. Consult them as much as you feel necessary to achieve this end.
- Do not obstruct the movements of the security services.

ASK FOR:

• The cooperation of all members of the audience in the event of an accident.
